## **Board of Directors Special Meeting**

May 12, 2023

# **CALL TO ORDER**

Eric Swartz, President, called the meeting to order at 9:03 a.m. Mountain time.

## APPOINTMENT OF CHAIRPERSON

A motion was made by Ron Bernard to appoint Brian Sbrocco as meeting chairperson. The motion was seconded by Hans d'Orville and unanimously carried.

Mr. Brian Sbrocco announced with all Board Members present, quorum was met.

# APPROVAL OF AGENDA

A motion was made by Ron Bernard to approve the Agenda as presented. The motion was seconded by Brian Sbrocco and unanimously carried.

# **DESIGN RENOVATION UPDATE**

David Fugett provided an overview of the mock unit design process and introduced Mac Montgomery and Jesse Bales to present the design renovation update. Highlights included:

- Mockup floor plan, existing conditions, and previously presented design options were reviewed
- The Board reviewed and discussed living and dining area option A, B, and C; primary bedroom option A, B, C, and D; and secondary bedroom option A, B, C and D
- It was reconfirmed that the existing dining table will be used and the height will be addressed and the bench and chairs will be made available in the model unit to review
- It was explained concepts can be blended once model room is completed
- Mr. Swartz expressed desire to take a few days to review
- Mr. d'Orville suggested the Board review options and either submit decisions or meet by Friday, May 19, 2023.
- Ms. Champagne noted if the Board would like to wait a week to 10 days it is possible the model installation may not take place in the fall, however the management team will do everything possible to complete a fall installation

A motion was made by Ron Bernard to meet with the Board at 9:00 a.m. Mountain time on May 19, 2023 to approve model room design. The motion was seconded by Hans d'Orville and unanimously carried.

## **OLD BUSINESS**

## **Association Website**

- Samantha Barry stated she reached out to eight different website companies and so far, has heard back from four. Only one company has provided an estimate, two others are expected to provide estimates. Purple Squirrel's estimate was for \$5,600, which includes 40 hours of work at \$140 hourly rate.
- Every effort will be made to obtain additional estimates to be presented during the next meeting.
- Mr. Sbrocco requested management obtain an estimate from Blue Tent if possible.
- The Board expressed concern regarding association compliance of Colorado Statues and urged Mr. Swartz to sign the documents related to collection policy and other governing documents.
- Mr. Gersbach requested Mr. Swartz sign all documents that he is comfortable with so that the association will be compliant with collection policy and other governing documents.
- Mr. Swartz stated he would like to speak with attorney before signing documents related to website housing documents. Mr. Gersbach will set up time so that he can speak with attorney, Carrie Wallace next week.

#### Vacant Board Seat

- Mr. Gersbach forwarded three candidate resumes to the Board to review to fill the vacant Board seat
- After a brief discussion the Board agreed to delay the appointment of a Board member
- The Board would like to solicit as many owners as possible and fill the vacant seat through a general election during the upcoming annual meeting
- Andrew Carter and Jami Champagne explained the Board is required to approve a budget, then send to the owners 30 days prior to the Annual meeting for ratification. Mr. Carter will review association documents for ramifications if the Board does not and will email the Board the results following the meeting
- Ms. Champagne suggested the Board could hold a pre-budget meeting to allow more discussion

A motion was made by Brian Sbrocco to delay board appointment. The motion was seconded by Ron Bernard and unanimously carried.
